The Solution:

Founded in 2011 by globally-renowned Microsoft MVP and SQL Server expert Denny Cherry, award-winning Denny Cherry & Associates Consulting (DCAC) has grown to be a Gold Competency Microsoft Partner that offers Microsoft MVP consultants capable of achieving optimal results faster and at lower Total Cost of Ownership than competitors.

DCAC proposed a Two-Node single instance SQL Server cluster for high availability in the event of a One-Node failure. With RISE running large financial transactions, this high availability was essential to the success of the business. The cluster would allow the infrastructure team to harden their ability to satisfy RPO/RTO compliance requirements & standards.

DCAC coupled this plan with a disaster recovery technology to a secondary geographically dispersed location, further helping to shore up the weak spots in Rise's DR agendas and capabilities.

For software, DCAC recommended using Windows 2012 R2, as this was what their primary application vendor could support. He would then move the application over, as well as the terminal server.

The Result:

The effect of DCAC's solution was immediately noticed in terms of performance and savings: payroll could be completed faster, with fewer staff resources.

Dee recalls, "With payroll, what used to take a team of four a week to process we now get done by one person in two hours. Billing has gone from a team of nine working 2.5 weeks to a team of seven completing in under a week."
